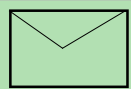
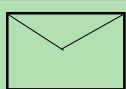

## Readers Write



### Strange Things Are Happening

Over the past several weeks the nation has been witnessing quite a few rather strange occurrences.

First there was the August 24, sudden and swift government take-over of the biggest telephone company in the land. Then, probably fearing a similar fate, the electricity company that has been threatening consumers with increasing blackouts in the wake of repeated rejection for rate increases, publicly announced that all is well and that its various sources of electricity supply are adequate to meet the demands and so there should be no need for blackouts.

Then there was the opposition's likewise swift action resulting in the removal of a vocal and veteran parliamentarian from the senate while that political party continues to retain a rookie southerner in the senate who is yet to make any meaningful contribution to a debate in that upper house of parliament.

Furthermore, the discoloration of the water in the Macal River has been going on for several months, while, except for a very few concerned citizens, not much relevance or attention appears to be given to rectify this condition which poses a real health hazard to the populace downstream who depend on the river as a direct source of water for livestock, agricultural and human consumption and as a source of income for those engaged in river activities for tourism ventures as well as the potential negative effect this condition would have on the nation's world heritage site as the sedimentation flows into the sea and onto the barrier reef.

There is also the case of policemen who continue on active duty although they were arrested and criminally charged with wounding a citizen. It used to be in times gone by that criminal charges against a policeman would result in instant interdiction from active duty.

We are also witnessing increasing instances where the magistrate continues to strike out criminal cases at an alarmingly high rate primarily for want of prosecution as in almost every instance investigating officers have failed to produce a case file. In one instance this week, the magistrate publicly announced nine instances where criminal charges were dismissed because the same policeman, in all nine instances, failed to submit files. While all of this is happening it seems like no one cares about why so many criminal cases are going down the proverbial drain as business continues as per usual while some of us sit and wonder why lawlessness continues to spiral out of control across the nation.

Additionally, the police high command is expressing concern about a new form of criminal behavior dubbed "*home invasion*", while this community witnessed one of those this week, the accused was released from custody less than 24 hours later and

the reason given is that the investigating officer was not conducting the investigation properly and in this particular instance the actions of the accused had the unpleasant smell of vigilante justice notwithstanding, business continues as per usual.

More recently we witnessed, for the very first time, the criminal charging of a serving elected politician on allegations of financial impropriety at a time when this politician's party holds the reigns of government.

### ANOTHER SALAZAR BOY FACING CRIMINAL CHARGES

rushed into the house and emerged with a machete. Upon seeing her son with the machete, the assailant reportedly fled and was joined by two other persons. Ismael informed that he chased behind the assailant and the two other male persons.

The mother immediately called the police while the girlfriend placed a call to Ismael's friend, **Oswald Twist Jr.**, who lives in Santa Elena Town. Twist reportedly arrived shortly thereafter in his small green car and when he teamed up with Ismael, a single gunshot broke the silence of the night. Ismael rushed inside his house and Twist reportedly felt a burning sensation in his left leg. Fearing for his life, Twist reportedly jumped in his car and sped off down 6<sup>th</sup> Street by this time the police were arriving in time to hear the single gunshot. Twist was speeding off and the police suspecting that he might have been the assailant, set chase after him but he did not reach far as he lost control of the car and ran into a nearby drain. Police pulled him from the car,

placed him the police mobile and rushed him to the San Ignacio Town Hospital. He was later transferred to the Belmopan Hospital where he was treated and later released.

Police investigations revealed that the accused, Joel Salazar, is former soldier of the Belize Defence Force who has been listed as absent from duty since March 9, 2009. He is listed by the military police as **Salazar J. #7452 - Deserter**.

The army is requesting that after the criminal proceeding, he be handed over to the Belize Defence Force for possible court marshal, imprisonment for 90 days, and dishonorable dismissal.

If the name of the accused sounds familiar to readers that's because he is a younger brother of **Donicio "Life" Salazar** the individual who last December walked free of a murder charge in the chopping death of the eldest son of the publisher of this newspaper who coincidentally or otherwise was also working as a bartender when his life was brutally ended.

## Micro-Grants Distribution In The Northern Districts

**ORANGE WALK TOWN, Wednesday, September 30, 2009:**

Thirty-two Micro-Grant contracts were signed and handed short ceremony today in Orange Walk Town.

The contracts were awarded to successful applicants engaged in small-scale Enterprise Development Programs in Agriculture and Tourism which was launched in the Orange Walk and Corozal Districts under the Accompanying Measures for Sugar, through the European Union and the Ministry of Agriculture and Fisheries and the Ministry of Labour, Local Government and Rural Development working in partnership with La Inmaculada and St. Francis Xavier Credit Unions.

**Yolanda Gomez**, Manager, La Inmaculada Credit Union and Chairperson of the Project Steering Committee explained that the grants handed out was the second disbursement; the first done in March of this year, from the total project fund of BZ \$863,000 for both credit unions.

A total of eighty micro-grant cheques to the tune of approximately BZ\$1,400 each will be distributed to successful applicants for the financing of individual projects.

Mrs. Gomez informed that the target group for this program was mainly poor small-scale farmers and families living within the rural Sugar belt communities of the northern districts with a focus on women and youth.

*"The objective of the project", said Mrs. Gomez, "is to improve on existing small-scale enterprise development; improving the livelihood of these persons and their communities through non-traditional Agriculture and Tourism such as small-scale fishing farms, beekeeping and the Arts and Craft."*

## Investment In Education Continues Almost \$30,000 pumped into SHC Computer Lab

**SAN IGNACIO TOWN, CAYO, Monday, September 28, 2009:**

The campus at Sacred Heart College in San Ignacio Town, Cayo was the venue this morning for the official inauguration of a refurbished computer lab.

In the keynote address, the **Hon. Erwin Contreras**, Minister of Economic Development, Commerce, Industry and Consumer Protection, said:

# More Investments In Education

## New Classrooms In Benque & Arenal Village

Two educational projects benefiting over 650 students in Benque Viejo del Carmen Town and Arenal Village in the Cayo District were inaugurated on Thursday, October 1st.

These two projects were implemented by the Social Investment Fund under the Commonwealth Debt Initiative (CDI) Program at a total value of \$560,012.00.

The first project located in Benque Viejo del Carmen will benefit over 500 students

attending Mopan Technical High School.

The project entailed the completion of a two-classroom concrete building which will be used as a wood and metal work shop.

The structure measures 25 ft by 60 ft and includes adequate bathrooms, proper work benches and storage areas. The new metal and woodshop was constructed away from the main building to protect other classes from the noise of the machinery.

The facility was constructed at a cost of \$196,724.000. The new building also comes furnished with \$118,288.00 worth of new equipment which includes numerous hand tools for the

wood and metal shop and the agriculture department, computer parts for the Information Technology Lab, a new refrigerator and several kitchen utensils for the Food and Nutrition Unit as well as 30 sewing machines, dry/steam irons and sewing accessories for the Sewing Room and 50 drawing tables for the Technical Drawing Section.

The second project is a new school building for La Inmaculada RC Primary School in Arenal Village.

The new school building was

constructed at a total cost of \$245,000.

The project is a 25feet by 85 feet building with a concrete roof. It will provide the school with two additional classrooms, bathrooms for the teachers, computer room/library and a kitchen. The kitchen will facilitate a feeding program in collaboration with the Ministry of Education through the Cayo District Education Center.

The Ministry of Education will be providing equipment for the feeding program. Parents will volunteer to cook and the school has secured support from a businessman, who has committed to assist with the

feeding program.

The additional classrooms at la Inmaculada RC Primary School will benefit some 156 students and will provide more space for the infants and allow the school to start a preschool program. Furniture for the new school building will be donated by way of the Belize Natural Energy Charity Trust Fund.



# Mennonites Raise Hell In The Pine Ridge

SANTA ELENA TOWN,

Spanish Lookout mennonites are raising hell and causing disturbances in the Mountain Pine Ridge Forest Reserve, Cayo District, Belize.

It was a sweltering hot May in Cayo and we decided to go spend the weekend up among the pines in the cool, clear air of Mountain Pine Ridge.

We thought we would stay at the campground at Augustine (*Douglas de Silva*) and do some bird watching, take day trips to the nearby waterfalls and caves and, in general, groove on the natural surroundings.

We arrived at Augustine at 3:00 PM on Friday and set up camp. I was impressed by the new bathroom facilities at the campground and took a cool, refreshing shower, and then went out to take some photos of the abundant birdlife.

At 4:00 PM everything changed and our tranquility was violently seized from us as a group of around 30 Mennonites roared into Augustine on motorcycles and four-wheeled off road vehicles.

Oh no, they are coming over to the campground! Sure enough, the entire Mennonite gang stormed into the campground and the adults began to set up as the youth commenced to stunt-ride their dirt bikes all over the area, roaring to and fro.

For the next two hours ten or fifteen teams of Mennonite riders, many of them seemingly no more than ten or eleven years old (legal???) zoomed noisily all over the place.

I complained to the police and BDF soldiers at the main office and they agreed that it was not right that the folks from



Spanish Lookout should cause such a disturbance but no one did anything.

I would also suggest that under-aged children driving ATV's at high speeds on public streets are actually dangerous for the citizenry and they were posing a threat to our safety.

After enduring this violent assault to our senses and the excessive noise caused by the Mennonites for more than two hours, I approached one of the adults with the Spanish Lookout group and asked him if they were going to quite down later. I told him that I could not enjoy the natural surrounding with all the children making such a racket all over the area. He said that yes, they would stop riding after dinner and added that they would be out riding all over Baldy Beacon the next day so things would quite down in the campground until they returned. I said, *"you Mennonites don't drink, right, so I guess that you will all go to sleep pretty soon, right?"*

I was thinking that I would have to abandon the campground since the presence of all the hell raising Mennonites was destroying our chances of being in harmony with nature. And things did quite down around 6:00 PM as the young ruffians ate their barbequed steaks and drank their mugs of Swiss Miss with Marshmallows. But by 7:00 PM they were back zooming and roaring all over the place with headlights defined by the dust they were kicking up. I gave up and we decided that our only hope of peace would be to abandon the campground and look for some other place to stay. We were driven out by the wild, hell raising Mennonites!

Fortunately the BDF soldiers took pity on us and allowed us to camp behind their headquarters where it was much quieter.

The next day, shortly after dawn, the Mennonite disturbances commenced again. I walked down the muddy road to the dam to get away from the noise and look for birds. When I got back to the ranger station around 9:00 AM a group of tourists were standing around waiting for their military escort to drive down to Caracol Maya Site. I saw that they were marveling at the antics of the Mennonite bikers roaring back and forth in front of them. I walked up to them and said: *"What we are seeing is very interesting. These are*

*Mennonites who, for hundreds of years, lived in humble quietude, trying to live their lives close to God and trying to honor that Biblical command to love your neighbor as you love yourself. Now they have gone totally insane. They drove us out of the campground last night utterly ignoring the fact that we were there first and that they were causing us considerable suffering. They should make up some tee shirts to wear emblazoned with the image of angry-faced children popping a wheelies on their ATV with the words: SPANISH LOOKOUT MENNONITES: BORN TO RAISE HELL!!!!"*

Well, that's all I have to say about this incident. As far as I am concerned since Mountain Pine Ridge and the Chiquibul National Park are preeminently *"nature reserves"* where tourists and nationals go to see wildlife and go bird watching the presence of ATV riders zooming noisily all over the place is INCOMPATIBLE with the stated purpose of the reserve.

With absolutely no rancor or hatred toward anyone and only with the desire that there be justice and that the rule of law prevails, I suggest that the Mennonite Rough Riders be banned from zooming all over Mountain Pine Ridge/Chiquibul National Park causing 99% of all tourist to suffer from their presence.

Oh yes, on this same weekend the Mennonites also made a roaring entrance into the site at Caracol disturbing all the wildlife and all the tourists present. Their behavior was extraordinarily abusive and insensitive toward all others present.

# Beware Of Expired Food Items

## There Is An Abundance Of Expired Goods Being Offered For Sale

The Consumer Protection Unit of the Belize Bureau of Standards is issuing a consumer food safety advisory regarding the sale of expired food items in the market.

During the month of September, Consumer Protection Officers, in collaboration with the Public Health

Department, have been out vigilantly surveying the domestic market, inspecting retail outlets with a focus on prices controls and unscrupulous business practices.

The findings of these inspections have revealed that **there is an abundance of expired goods offered up for retail sale.** Consumers are advised to look out for the following:

Beware of reduced prices. The tendency is to sell food

items that are about to expire or that have already expired at reduced prices.

Retailers have a tendency to obscure the expiry date from consumers by placing the price of the good directly above the expiration date.

The tendency exists to erase the expiry date with alcohol or to remove the label with the date.

Expired food items are being sold in smaller or individual packets, out of the original packaging. These are items that

are not intended for retail sale.

Food Items are removed from outer package and put up for retail sales and subsequently sold in the inner foil/plastic, for example: Corn Flakes/Cereals. In this instance the expiry date is unknown.

Also, there is a tendency to conceal expired commodities in storage facilities, claiming they were destined for destruction or to return to suppliers when found.

In accordance with the Food and Drug Act Chapter 291, Section 12, food unfit for human consumption should not be offered for sale or in possession for the purpose of sale.

Expiry dates indicate the period of time which a food item is fit for human consumption. Consumers are advised not to purchase commodities that are taken from their original packaging; this is a clear indicator that the product has already passed its consumption period.

When shopping for food items ensure that the product has an expiration date before purchasing.

Do not expose yourself to the risk associated with consuming expired food items.

above the right eye and another to the upper right arm.

The accused murderer was initially detained by the village Chairman near the scene of the crime and the suspected murder weapon, a machete, was recovered from nearby bushes.

While it is alleged that the accused and the victim were drinking at a bar in the village, the accused maintains that he was never socializing with the victim whom he describes as *“an alien and trouble maker in the village.”*

On a point of interest, the accused is a primary witness in a 2007 murder case in which his 17 year old nephew, **Samuel**

**Tesecum**, was hacked to death allegedly by one **Emilio Morales** who is currently on remand at the Central Prison in Hattievville.

During the April 2008 preliminary inquiry hearing, he was extremely reluctant to sign the witness bonding over form in the presence of the accused, **Emilio Morales**. On this occasion he told the court that he did not want to testify at the hearing because he was receiving constant threats from friends of the accused who visited Morales regularly in jail one of which is said to have been the deceased.

He eventually agreed to sign the form thereby consenting to

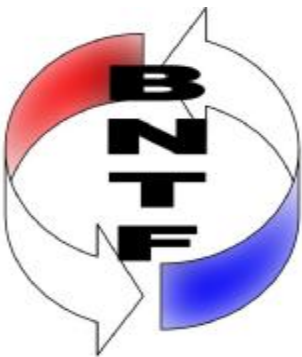
